Marketplace Redetermination Process – How Will It Work?

This document – *Marketplace Redetermination Process – How Will It Work?* – outlines the redetermination processes that are proposed for use in the Federally-facilitated Marketplace (FFM) and identifies options for redeterminations that may be used in the State-based Marketplaces (SBMs). A “redetermination” involves an assessment of an individual’s eligibility for a subsequent year of health insurance coverage through a Marketplace, possibly including eligibility for advanced premium tax credits (APTCs) and cost-sharing reductions (CSRs), and includes the process for enrollment in a health plan for the 2015 coverage year.

The redetermination procedures are designed to enable current enrollees in health insurance coverage through a Marketplace to retain coverage even if the enrollee does not respond to notices from the Marketplace to request re-enrollment. **Current enrollees, though, are encouraged to contact a Marketplace in order to: (1) provide updated information, if any; (2) authorize the Marketplace to access information from the Internal Revenue Service, if needed; (3) receive an updated determination of the type and amount of federal financial assistance available; and (4) review health plan options for 2015 and consider selecting a different health plan, if warranted, rather than be assigned to a health plan using.....**
