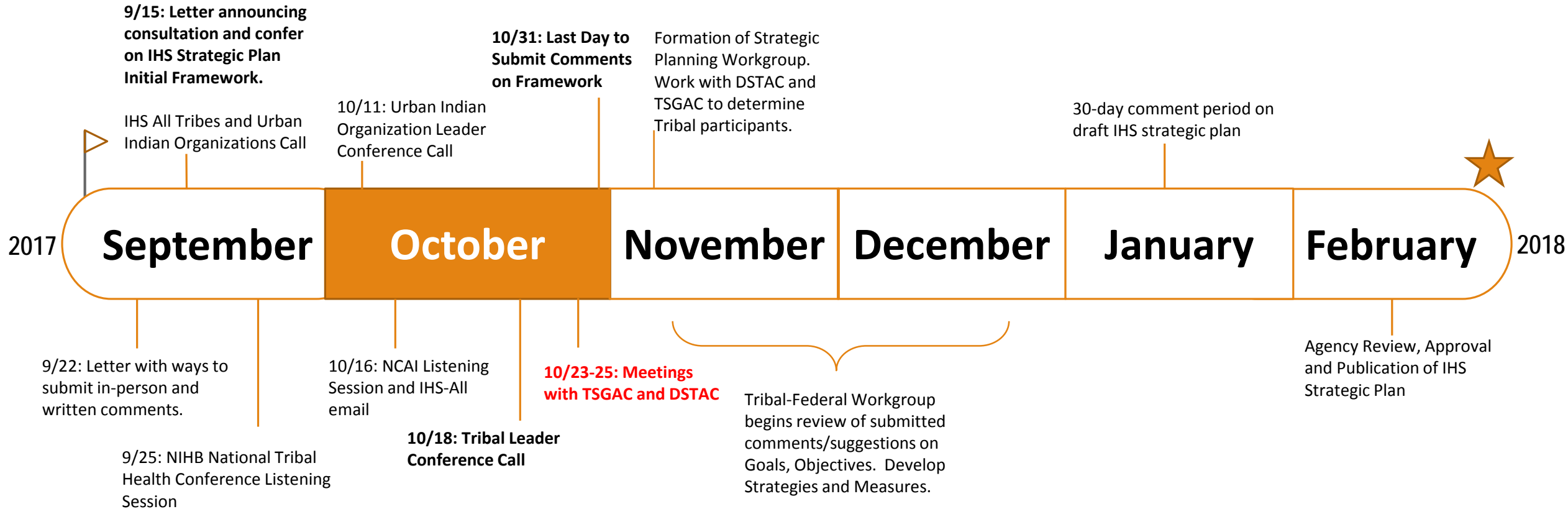

- Next Steps
  - Formation of Workgroup
  - Workgroup review of comments and develop draft plan
  - Issue 30-day comment period for draft plan
  - Publication of final plan



# Workgroup Sketch

---

- Purpose
  - Draft final mission, vision, goals and objectives with appropriate strategies and measures.
  - The final workgroup documents and recommendations will be reviewed by senior staff and a final 30-day comment period.
- Composition
  - Tribal Representatives
  - Area Representatives
  - Headquarters Office staff
  - Senior staff
- Meeting Timeframe
  - Five meetings starting early November thru early December
  - Weekly meetings with additional time for workgroup activities and assignments
