RESOLUTION NO. 16-423

1	WHEREAS,	the 100000 0 dutam Legislative Council is vested with the power to promote,
2		protect and provide for public health and general welfare of the Tohono
3		O'odham Nation and its members" and with the authority "to consult with the
4		Congress of the United States and appropriate federal agencies regarding
5		federal activities that affect the Tohono O'odham Nation" (Constitution, Article
6		VI, Section 1(c)(2) and Section 1(j)); and
7	WHEREAS,	at the recommendation of the self-governance tribes, representatives from the
8		self-governance tribes and Indian Health Service staff developed guidelines for
9		establishment of a Tribal Self-Governance Advisory Committee ("TSGAC"); and
10	WHEREAS,	TSGAC provides information, education, advocacy, and policy guidance for the
11		implementation of self-governance compacts with the Indian Health Service;
12		and
13	WHEREAS,	the TSGAC's membership consists of a primary and an alternate representative
14		from each of the IHS areas that have self-governance tribes, and a technical
15		representative; and
16	WHEREAS,	the Health and Human Services Committee recommends nominating
17		Representative Daniel L.A. Preston, III as the primary representative to TSGAC,
18		Representative Anthony J. Francisco, Jr. as alternate, and Department of Health
19		and Human Services Acting Executive Director Veronica Geronimo as technical
20		representative.
