primary delegate for the TSGAC. She is qualified to represent the views and has the authority to act on behalf of the Great Plains tribes. Additionally, Danelle Smith, Chief Executive Officer, Winnebago Comprehensive Healthcare Systems was nominated as the alternate delegate to the TSGAC pending the selection of a tribally elected leader. Likewise, Jerilyn Church, CEO for the GPTCHB, was nominated to

serve in role of technical advisor for TSGAC.
