The Confederated Salish & Kootenai Tribes (CSKT) developed a Tribal Civics curriculum to educate their citizens with a unified body of knowledge that will help them know their history and empower them to exert and protect their tribal sovereignty. To cultivate well informed citizens, CSKT developed a curriculum that includes educational videos, lesson plans, and posters that includes tribal history, important court cases relevant to CSKT, aboriginal rights, treaty rights, self-governance and why CSKT operates the way it does today.

It's important for Tribes to reaffirm their sovereignty by educating their own citizens in a more systemized matter to ensure vital information regarding their rights and responsibilities gets passed along. The Tribal Civics curriculum is owned by CSKT, and the materials can be added to and updated. In this session, Tribal Nations will learn what a tribal civics curriculum could look like for their own citizens and get ideas on how to develop one.

The survey had very specific questions and data that would be beneficial to planning programs and grant funding. The Osage Nation had a very robust response, over 4,500. The survey was open for two months and was available on our website electronically as well as by hard copy on request to all Osage Nation citizens. The U.S. Census suggested Osage Nation participate in a pilot project with the US Census to share data and information. An MOU is being developed as to what data and security measures will be taken.
