Attached to this memo are brief descriptions of the external committees I am seeking QIN appointment by QBC Resolution. All three convene on a quarterly basis and include the annual self-governance conference, strategy session, and trainings:

SGCETC - Self-Governance Communication and Education Tribal Consortium

The Self-Governance Communication and Education Tribal Consortium (SGCETC) is a non-profit 501(c)(3) consortium of Tribal nations that elected to use Self-Governance for the delivery of programs and services for their citizens and communities. SGCETC strives to assist all Tribal nations to achieve their own goals of self-government and seeks to ensure that the tenets and purpose of Self-Governance are accurately communicated and clearly understood by Congress, the Administration, Tribal nations and all other interested parties.

BIA SGAC - Self-Governance Advisory Committee

The Department of the Interior's (DOI) Self-Governance Advisory Committee (SGAC) provides a forum for Tribal and Federal officials to discuss issues related to Tribal administration of Federal programs and services, exchange ideas, and develop solutions intended to improve Self-Governance and enhance the Tribal-Federal partnership. SGAC membership consists of a Primary and an Alternate representative from each of the BIA Regions that have Self-Governance Tribes. The Primary and Alternate SGAC members from each region also select two persons to serve as official members of the SGAC Technical Workgroup.

IHS TSGAC – Tribal Self-Governance Advisory Committee

The Indian Health Service (IHS) Tribal Self-Governance Advisory Committee (TSGAC) provides a forum for Tribal and Federal officials to discuss issues related to Tribal administration of Federal programs and services, exchange ideas, and develop solutions intended to improve Self-Governance and enhance the Tribal-Federal partnership. TSGAC membership consists of a Primary and an Alternate representative from each of the IHS Areas that have Self-Governance Tribes. The Primary and Alternate TSGAC members from each region also select two persons to serve as Official Members of the TSGAC Technical Workgroup.
