Section 105(l): Using Leases to Collateralize Construction & Leverage Loan Guarantees

Section 105(l) of ISDEAA allows Tribal Nations to be compensated for costs incurred while carrying out select federal programs, services, functions, and activities administered under Self-Governance agreements at Tribal facilities. Opportunities available under 105(l) leases have resulted in some creative options on lease designs and use of funds, including leveraging these funds for loan guarantees and collateralization of funds for construction.

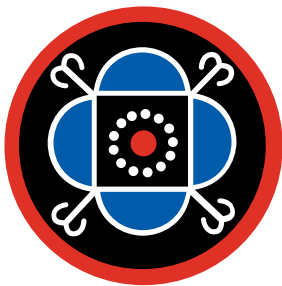
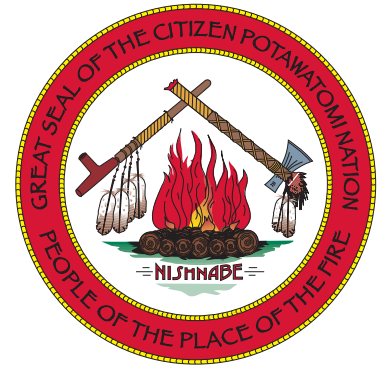
